



## Articulation Agreement

Between

**College of the Muscogee Nation and  
Southern Nazarene University**

**1. Purpose:** The purpose of this agreement is to establish a formal articulation agreement between the College of the Muscogee Nation (CMN) and Southern Nazarene University (SNU) for the transfer of students who have successfully completed designated associate degree programs and/or transferable college credit hours at CMN to specific bachelor's degree programs or to General Education courses at SNU.

**2. Transferable Credits:** CMN students who have successfully completed the following associate degree programs and/or transferable college credit hours will be eligible to transfer credits to SNU-Tulsa:

- Associate of Arts in Native American Studies
- Associate of Science in Tribal Services
- Associate of Science in Criminal Justice
- Associate of Science in General Studies
- Associate of Science in Natural Resources
- Associate of Applied Science in Gaming

**3. Transfer Credit Evaluation:** SNU-Tulsa will evaluate the transferability of credit hours based on the following criteria:

- Such credit hours appear on an official CMN transcript as earned credit.
- The transferring student earned a recorded grade of D- or higher, Pass, or other passing grade as indicated on the CMN transcript.
- Credit hours will be assigned to the appropriate SNU General Education and/or Electives areas during initial transcript assessment and academic advising review.

**4. Admission Requirements:** CMN students who meet the following requirements will be eligible for admission to Southern Nazarene University:

- Cumulative Grade Point Average of 2.0 or greater
- Admittance with Academic Warning (if GPA is 1.99 or lower)
- Official transcripts from all colleges or universities attended
- Completion of online application

**6. Financial Aid and Academic Advising:** CMN and SNU will collaborate to provide financial aid services and academic advising services to students transferring between the two institutions.

**7. SNU Information:** SNU will provide printed and electronic information packets to CMN students and advisors, which will include tuition, fees, locations, Title IV Aid, Tribal funding, and scholarships.

**8. Liaisons:** CMN and SNU will identify and appoint liaisons to facilitate coordination and administration of this agreement.

**9. Agreement Duration and Modification:** This agreement shall remain in effect until terminated in writing by either party. Either party may initiate modifications to the agreement by providing written notice to the other party. No modifications will be considered final or in effect unless agreed upon and approved in writing by both parties.

**10. Dispute Resolution:** Any disputes arising from this agreement shall be resolved through mediation by designated people of the Signatories below.
